DAC® HERBAL RESPOND provides a trace mineral profile suitable for all classes of mature horses. Minerals play a critical role in numerous metabolic functions including: reproduction, bone development, nerve function, immune function, hoof, skin and coat quality as well as energy balance.

Yucca Schidigera Extract – Active components of yucca include steroidal saponins and polyphenolics such as resveratrol and yuccaols. Yucca phenolics also are antioxidants and free-radical scavengers, which may aid in suppressing reactive oxygen species that stimulate inflammatory responses. Antioxidants are believed to reduce inflammation and pain by scavenging free radicals, which are thought to trigger tissue inflammation at the cellular level via oxidative reactions. Yucca has also been known for its ability to reduce ammonia (NH3) from animal waste. The **Yucca Schidigera Extract** used in **DAC**® **HERBAL RESPOND** is a high quality source provided by Alltech® branded De-Odorase®.

Devils Claw – (*Harpagophytum procumbens*) is a plant of the sesame family, native to South Africa. The two active ingredients in Devils Claw are harpagoside and beta-sitosterol. It is thought that these have anti-inflammatory properties.

Boswellia Extract – Boswellia is a genus of trees known for their fragrant resin which may have anti-inflammatory properties.

Vitamin C - Antioxidants are believed to reduce inflammation and pain by scavenging free radicals, which are thought to trigger tissue inflammation at the cellular level via oxidative reactions. Vitamin C is considered an effective antioxidant.

FEEDING DIRECTIONS

DAC° **HERBAL RESPOND** can be fed with either fortified or unfortified grains. Fortified grains contain added vitamins and minerals. Feed **DAC**° **HERBAL RESPOND** at the following rates:

Mature Horse

Loading Dose:	Feed two scoops (2 ounces) per horse per day for the first 30 days of product use.
Maintenance Dose:	Feed ½ to one scoop (1 ounce) per horse per day after 30 days of product use.

Feeding rate based on 1000 lb. horse.

CAUTIONS: Safe use in pregnant animals or animals intended for breeding has NOT been proven. If animal's condition worsens or does not improve, stop product administration and consult your veterinarian. Not for use with anticoagulants, salicylates or NSAIDs. Use with caution in animals at risk for GI ulceration; turmeric may be a GI irritant. Use with caution in horses that are bleeders and with long-term use due to tannin content. An examination from a veterinarian is recommended prior to using this product.
